

## **Asian Avant-Garde Film Festival Day Pass (29/5, 30/5, 31/5) Terms & Conditions**

1. Admission is available to all ticketed programmes on the selected day of the Asian Avant-Garde Film Festival 2025 (29/5 Day Pass, 30/5 Day Pass, or 31/5 Day Pass). Each barcode can only be scanned once for each ticketed programme. Please keep your e-ticket safe.
2. Admission is for one person aged 18 or above only for each ticketed programme.
3. Limited Day Passes are available on a first-come, first-served basis.
4. The Day Pass is non-transferable.
5. The Day Pass cannot be exchanged nor refunded.
6. The Day Pass is valid only for the selected date (29 May 2026 for 29/5 Day Pass, 30 May 2026 for 30/5 Day Pass, or 31 May 2026 for 31/5 Day Pass) and cannot be used on any other day.
7. Entry may be refused if any details on the Day Pass have been omitted or altered, or if the Day Pass is damaged, defaced, or otherwise mutilated.
8. Holders of concessionary Day Passes will be admitted only upon presentation of acceptable proof of eligibility.
9. Screening programmes in M+ Cinema Houses 2 and 3 will loop throughout the selected day. Seating will be limited, and will be available on a first-come, first-served basis.
10. For live events, latecomers will be admitted only if there is a suitable break in the event.
11. Day Pass holders must provide proof of age if requested by the Venue Manager.

## **亞洲前衛電影節日票通行證 (29/5、30/5、31/5) 條款及細則**

1. 亞洲前衛電影節 2026 日票通行證 (「29/5 日票通行證」、「30/5 日票通行證」或「31/5 日票通行證」) 適用於所選日期當天的所有收費節目。每組條碼只能於每個收費節目使用一次。請小心保管電子門票。
2. 每張日票通行證僅供一名年滿 18 歲或以上人士參與當天的每個收費節目一次。
3. 日票通行證數量有限，先到先得，售完即止。
4. 日票通行證不得轉讓。
5. 日票通行證一經售出，恕不退換或退款。

6. 日票通行證僅於所選日期當天有效（「29/5 日票通行證」於 2026 年 5 月 29 日有效、「30/5 日票通行證」於 2026 年 5 月 30 日有效、「31/5 日票通行證」於 2026 年 5 月 31 日有效），其他日期則無效。
7. 如日票通行證上的資料被刪去或經過塗改，或通行證遭損毀、污損或變得殘缺不全，則持票人士可能不獲入場。
8. 日票通行證特惠票持有人必須出示有效的身分證明文件，方可入場。
9. M+戲院 2 院及 3 院的放映節目，將於日票通行證所選日期當天循環放映。座位有限，先到先得。
10. 現場展演活動開始後，遲到者須待適當時候方可入場。
11. 場地經理有權要求日票通行證持有人出示年齡證明文件。
